The Central Noble Community School Corporation Board of Education met in regular session on Monday, August 15 at Central Noble Administrative Offices.

With no further business, the meeting moved to Superintendent Comments:

Mr. Morgan noted that iRead official scores have been released and happily announced that our scores were 7.1% higher that our surrounding districts. The hope is to continue seeing success with the Amplify curriculum in place.

Dr. Younghans, Mrs. Hoover & Mrs. Vice all spoke on the smooth start and excitement in the buildings last week. They also noted record attendance at open houses.

Mr. Bremer noted that athletics are officially in full swing starting with this week. He also noted the progress on the new score boards.
